Individuals with higher weights and comorbid eating disorders experience significant physical and mental health concerns that are much greater than those who only have one of these conditions. Disordered eating that most commonly occurs in this population includes binge eating and night eating, but it can also include bulimia nervosa and atypical anorexia nervosa. Individuals with these conditions often feel shame disclosing these issues due to fear of judgement and weight bias. This full-day seminar will discuss how to identify and diagnose disordered eating, the psychiatric comorbidities commonly presented in individuals with higher weights, and how to apply cognitive behavior therapy principles to treat these conditions.

Discussion will also include the use of these therapeutic modalities for the management of mood disorders, anxiety disorders and will touch on effective therapies to help with insomnia.

Discussion will include how traumatic stress manifests in children/adolescents and ways to include caregivers in supporting youth in developing tools for coping. The workshop will review normal sexual behavior versus problematic sexual behavior, and how to determine when intervention is necessary. The causes of problematic sexual behavior, the trajectory for children who exhibit these behaviors, and best practices for treatment will be covered.

This annual seminar will provide three hours of continuing education in ethics, law, professional conduct and risk management to satisfy Maryland licensure requirements.

Counselors and therapists are confronted daily with ethical decisions that also often have legal standing. Codes of Ethics exist to protect public health and safety. They define professional practice standards and are the basis of legal statutes and regulations mandated and enforced by the State of Maryland. Compliance with ethical & legal mandates not only constitutes best practice but also is required to maintain a professional license. This seminar will examine the core ethical principles of Autonomy and Justice and practical implications for treatment decision making. Ethical guidelines, social policy issues & legal mandates concerning consent to treatment, confidentiality, HIPAA, mandated reporting, record keeping & termination will be discussed as well as appropriate treatment for children and offenders caught up in the legal system.

The Relationship Enhancement® (RE) Model is a psychoeducational program and brief therapy model that employs a skills-training methodology for empowering distressed couples and families. The seminar will focus on ten RE skills: Empathic, Expressive, Discussion/Negotiation, Problem/Conflict Resolution, Facilitation, Conflict Management, Self-Change, Helping-Others Change, Generalization and Maintenance. How RE therapy equalizes power within relationships, both between genders and across generations will be discussed.
