Understanding & Addressing the Complex Web of Childhood Abuse and Traumas Understanding Yourself and Others through the Lens of Trauma, Dignity, and Adaptation

This CE will address the following questions:

- What really is informed trauma care? What does it mean for me professionally and personally?

A Taste of Trauma: An Intro to Trauma Informed Care

Fred Edell, LCPC, holds a Master's in Theology and integrates faith into his counseling. Specializing in trauma, mood and anxiety disorders, ADHD, and OCD, he works with individuals, families, and groups. He is a Certified Trauma-Focused CBT practitioner and an Approved Supervisor in Maryland.

Session A To evoke awareness, empathy for those who are traumatized and interest in causes, effects, healing and recovery in the context of our work and relationships

Implicit Bias: Working with Students (Cultural)

Session B

Description: Research shows implicit bias affects student outcomes in areas like discipline, grading, and achievement expectations. This workshop explores how bias manifests in education and provides strategies for recognition and reduction. Participants will engage in self-reflection and leave with practical tools to promote more inclusive, equitable learning environments.

Inclusive Futures: Effective approaches for Supporting Young People with Autism Sarah Bendekovits, PhD, BCBA-D, LBA, is the Clinical Director of ABA Services for Washington County, MD, and parts of WV. She began as a behavior technician in 2018, became a BCBA in 2021, and earned her PhD in 2024. Passionate about mentorship and skill generalization, she supervises BCBAs and advocates for client success in less restrictive environments.

Description: This session explores the impact of social media on children and adolescents, highlighting both its Session H benefits and risks during crucial stages of brain, identity, and social development. Topics will include vulnerabilities of the young brain, the psychological and behavioral effects of social media, and strategies for therapists and parents to promote healthier media use.

Session I

Sarah Gann, began her human services career in 2022 and now serves as the Medical Navigator for CASA, Inc. within Meritus Health's Forensic Nurse Program, supporting survivors of IPV, sexual assault, and sex trafficking. Sarah is working toward her M.A. in Forensic Psychology and LCPC licensure.

Description: This course explores strategies to help adolescents build healthy relationships, recognize risks, and navigate challenges like digital interactions and peer influence. With 1 in 12 youth experiencing dating violence annually (CDC), attendees will learn to identify warning signs, provide support, and advocate for young people.

- Identify known risk factors and consequences of unhealthy relationships in youth
- Identify strategies to build healthy relationships in youth
